- 3. A color copy of valid photo ID for all applicants.
- 4. Current copy of pay stubs or other proof of income for one month or more.
- 5. Signed signature page stating you've received the Rules & Regulations.
- 6. Application Fee \$50 per applicant (18yo+) paid by one of the following ways:
  - a. Money Order (no personal checks) made payable to The Lannan Company, Inc.
  - b. Venmo-Search @LannanCompany under Business

Upon receiving the completed application package and application fee, I will initiate the credit/background check for all applicants 18yo+. Each applicant will receive an email from TransUnion SmartMove to register an account, answer financial/personal questions to verify your identity, and authorize the credit/background check.

If the applicants are approved, we will need to review a draft Warranty Deed from an Attorney or Title Company. We require a minimum notice of five (5) business days prior to closing to arrange for an Amherst Gardens owner's signature on the Landowner Consent of the Deed.

Management will complete an exterior inspection of the home and may require repairs prior to approval.

The buyers and new residents are not approved to purchase the home or live in the community until we sign the Park Approval Form.

Immediately upon Closing, we require notification from the Attorney or Title Company so we can update our records with new owner info.
